



HIGH STAINDALE & MOORCOCK MEADOW CAMPSITES

The sites are provided for use by Scouts, Guides and other organised youth groups. They are not a public campsite.

There are 3,500 hectares of forest to explore. Permanent Orienteering course at Adderstone and Seivedale, cycle hire at Dalby Bike Hub, Aerial adventures and Segway at Go Ape, and group activities such as archery at Dalby activity Centre, ask us for details. The Visitor Centre is at Low Dalby.

High Staindale Campsite

Size	Approx 85m x 30m
Aspect	Sheltered – South westerly
Facilities	Hard limestone road connecting site to Forest Drive. Spring water and chemical toilet waste disposal point available on site. Campfire/Barbecue area – Use is dependent on forest fire hazard rating.

Moorcock Meadow Campsite

Grid Reference	SE 892 888
Size	Approx 1 hectare
Aspect	Plateau top – sheltered on 3 sides by trees. Day long exposure to sunlight.
Facilities	Hard limestone road connecting site to Forest Drive. Spring water and chemical toilet waste disposal point available at High Staindale, (2 miles by vehicle). Spring water tap available at Moorcock Meadow. Campfire/Barbecue area – Use is dependent on forest fire hazard rating.

General to each campsite:

Charges	£3.00 per person per night and includes parking charges. All vehicle registrations need to be submitted to staff at the Visitor Centre for access and egress during your stay. Cheques payable to Forestry Commission Card Payment accepted

HIGH STAINDALE & MOORCOCK MEADOW CAMPSITES SITE RULES & GUIDANCE NOTES

Please ensure that you have read and understood the site rules. Acceptance is a condition of any booking.

1. The sites are provided for use by Scouts, Guides and other bona fide organisations. They are not public campsites. They may be used only by prior booking.
2. Please arrive on site after 2pm and depart before 11am unless other arrangements are made at time of booking.
3. Please be considerate to the local residents in the forest. Please limit your noise and disturbance to reasonable levels during daytime hours and avoid all noise and disturbance at night time.
4. There are no facilities in the forest for the disposal of rubbish. All waste must be removed by the site user.

If campsite rubbish is left by users, the Forestry Commission reserve the right to levy a clearance charge of a minimum £70. Charging will be at the sole discretion of the Forestry Commission.

Chemical toilets and wash facilities are the responsibility of the site user. These need to be hired in advance and are available from Loos2ewe (call 01723 582346 or email info@loos2ewe.co.uk). The use of the public toilets at Staindale is not permitted. Site users can use their own chemical toilet, but these must be emptied at the sanitary toilet unit at the High Staindale campsite. Pit latrines are not permitted at any of the campsites.

5. Please use the designated area for ground campfire. Firewood may be scavenged from the forest area, i.e. fallen branches, dead windblown trees. On no account must live trees be cut or other wooden constructions be used. Chainsaws must not be used. Campfires may not be permitted during periods of high fire risk. Any damage may be charged, at the sole discretion of the Forestry Commission.
6. Drinking water is supplied from a standpipe at each site.
7. Staindale Lake is for wildlife enhancement and conservation. Bathing and other water based activities are not permitted.
8. If you wish to carry out specialist activities in the forest which may require a permit, contact Chrissie Hickes (Recreation Admin Officer) Telephone 03000674300
