- To take your litter home.
- That wildfires, campfires and stoves are banned on Forestry England Crown land. It is a fineable offence to light fires of any type.
- Participants must follow all signs and stick to the wide, main gravel tracks and not to follow the little pony paths in bird nesting season. These often lead to sensitive wetland habitats and ground nesting bird areas. This will allow the birds to find quieter, less disturbed areas of the forest to breed and rest.
- Assessors, leaders and parents please do not to park in front of gateways on or on grass verges.
