We are looking for outline business proposals for the Chapel Hill building. The property comprises a self-contained barn conversion providing open plan office and storage over two floors with ancillary staff / WC facilities. Shown red on attached plan. Mains supplies of water and electricity are available and connected to the property.

Location

The Chapel Hill property occupies a secluded position within Willingham Woods, LN8 3RQ. Access is via a forest road.

Willingham Woods is part of a large complex of pinewoods that are located, approximately 2 miles, east of Market Rasen and 20 miles from Lincoln. Gainsborough, Scunthorpe, and Grimsby are all within a 25-mile driving distance. The communities of Skegness, Sleaford, the east Lincolnshire coastline, Newark on Trent, and parts of Hull are within 1 hour drive time.

Background

Willingham Woods provides a diverse range of recreational opportunities as well as an important source of timber. It is managed as part of a wider of complex of woodlands across northern Lincolnshire (East Beat).

East Beat covers the geographical area of northern Lincolnshire and includes the Lincolnshire Limewood National Nature Reserve which is the largest area of lime woods in Europe, is ecologically very important with significant visitor numbers and produces significant volumes of valuable timber. Also included are the more mixed woodlands around Market Rasen where the successful integration of timber production, nature conservation and public access are similarly important.

As a working woodland there will be various operational activities throughout the year including harvesting and tree management.

The woodland is visited all year round but is especially popular during the summer months, when holidaymakers use it as a break point whilst heading to and from the coast.

A walking trail

Cycling and mountain biking

Horse riding by permit only

A permanent orienteering course

Various picnic areas

There is a council owned layby and small catering unit adjacent to the parking entrance to Willingham Woods. This is outside the scope of this document.

How to respond

Forestry England invites the market to respond to support and inform development decision making, and any future subsequent tender or lease for the future business opportunities at Chapel Hill.

To this end we would welcome written submitted proposals (not exceeding 4 sides of A4 paper) from potential interested parties indicating the following:

1. Their likely interest in a tender or lease arrangement for the Chapel hill building as outlined above
2. Your business name, registration and contact details
3. A proposal of business ideas that could be adopted into any potential development to include:
 - a. An overview of the proposed business and which space it relates to
 - b. The benefit the proposal would bring to Chapel Hill and Willingham Woods; what services/goods could be provided and how this would increase the draw for visitors
 - c. How this would complement and meet Forestry England's strategic direction
 - d. If applicable, examples of where this business model is already in operation
 - e. Likely/High level figures for annual turnover likely to result from proposed visitor numbers against the business ideas
 - f. Any other suggestions or options considered relevant on how value could be added to these business opportunities

Responses are required to be a summary only, and participants are not required to provide detailed business plans at this stage. To minimise internal resource and in anticipation of high numbers of respondents to this opportunity, please do not send any general marketing material in response to this request.

Interested parties should not provide any personal information, and any commercially sensitive information should be clearly marked. The Forestry Commission confirms that it will keep confidential and will not disclose to any third parties any information submitted as part of this market engagement exercise.
