Agenda items

1. Welcome

| Item Lead: Sir William Worsley

The Chair welcomed members to the nineteenth full meeting of the Forestry England. The apologies of Mike Seddon and Gurch Randhawa were accepted.

Chair's update

The Chair noted:

- recent meetings held with the new Secretary of State and Forestry Minister, and their engagement with the work of Forestry England and the wider Forestry Commission, in London, Rendlesham and Whinlatter forests.
- his visit to Wild Ennerdale for its declaration as a National Nature Reserve
- the recent decision by the Commissioners on a disputed case.

Forestry commission family updates noted:

Forest Services: issuing of £10m under the Woodland Carbon Accelerator Fund, the opening date of next round of applications to the Development Woodland Officer programme, oversubscription to the first round of the Seed Sourcing Grant and involvement in the development of the Local Nature Recovery scheme.

Forest Research: filming of Countryfile at Alice Holt, the appointment of the new Head of Science centre, and the publication of the UK Forestry Standard Practice Guide on designing and managing forests and woodlands to reduce flood risk.

Forward look: the next meeting of the Commissioners is 8 December, FC CEO will be speaking at the CONFOR conference on 8th December and Chair and FC CEO will be attending the Woodland Trust 50th Anniversary reception at the Houses of Parliament 20th Dec.

2.1 Declarations of Interest

There were no declarations for the meeting. Updates to William's register noted.

2.2 Approval of Board minutes

The minutes of the Forestry England Board meeting 21.09.2022 were agreed as a true record.

4. M7 Finance report

| Item Lead: Amanda Grist

Amanda took the Board through the M7 Finance report. She noted that since the previous Board meeting in September measures had been put in place to manage both pay and nonpay costs. Whilst this resulted in gains, these had been offset by a fall in timber prices and losses in PSS, which resulted in a trading income £3.7m less than forecast, with an overall deficit of £9.5m to budget. We are maintaining the £7m cash floor, there is £35m free cash.

The following points were raised in discussion:

- How timber is presented in the accounts -Amanda noted comments. The new management accountant will consider this.
- Review of cash floor of £7m to be considered as part of the Business Plan submission
- Current discussion on ASL and future funding options noted
- Question asked at what point do we decide not to catch up on underspend This has been considered as part of recent financial interventions. It was noted that deferring some works may result in overall higher costs over the long term (e.g. restocking)

Paper Title: Bench marking the efficiency of Forestry England's operations

Paper requirement and action required by Board:

- 1. To consider, and comment on, the proposal to award a consultancy contract which will provide bench marking information on our operational efficiency.
- 2. To provide a steer on areas of bench marking investigation which are most likely to provide valuable insight into our operational efficiency.

Communication headlines

- Operational efficiency is an important aspect of Forestry England's performance and comparing ourselves with similar organisations is a useful way to gain insight.
- We last reported on organisational bench marking in 2017, before Forestry England
 was established under its current Board. We believe the time is right to undertake a
 fresh investigation of our operational efficiency covering a range of high level
 organisational metrics and more detailed metrics focused on land management.
- We will appoint a suitably experienced consultant to assist us with this work and task them with reporting back to us in a way which provides both valuable insight and suggestions for efficiency improvement.

Purpose

This paper;

 Alerts the Board to our proposal for a bench marking investigation of our operational efficiency and seeks their input into the development of the final consultant's brief.



• For reference, provides the Board with sight of the previous bench marking report produced by Poyry Consulting Ltd in 2017.

Background

Forestry England wishes to use external benchmark information, building on the work undertaken in 2017/18, to compare and contrast Forestry England's high level performance with private, charitable and public organisations operating in a similar field.

Efficiency benchmarking is a valuable analysis supporting Forestry England's continued business improvement. Since 2010 Forestry England has pursued a strategy to increase its net income from traded and other non-Government sources and is currently c.80% self-financing. The development of new income streams (e.g. additional charged for car parks or nutrient credits) in combination with business practices to reduce cost or gain efficiencies (e.g. regular tendering for services or innovation in PSS reducing labour needs) have contributed to this good performance.

Undertaking efficiency benchmarking at this time can serve two purposes:

- Contributing to factual evidence as to the overall efficiency of Forestry England relative to peers. This is valuable for advocacy within Government and directing continuous organisational improvement at the strategic level.
- Focussing internal efforts to improve net financial performance of the business overall and in specific areas of activity.

While re-assessing the overall efficiency of Forestry England relative to peers, we wish to specifically consider our efficiency of land management activities. The effectiveness timber sales and marketing practices was externally reviewed in 2016, revealing this area of activity to be performing in line with its international peers. However other areas of land management activity have not been subject to external review for over a decade.

We wish to focus on land management activity specifically because significant and relatively recent external consultancy or audit reports have or are contributing to ongoing development and evolution of our recreation, leisure, and estates activities.

Proposal

As described above, we envisage two components to this benchmarking work.

Organisational level efficiency benchmarking. We will steer consultants towards repeating, rather than reinventing, the work done in 2017. We are mindful that the period since the previous study has included both the economic impacts of the pandemic and the war in Ukraine and, therefore, the time period for comparison cannot be described as 'normal operating conditions'.



Work activity level benchmarking. Here we want to develop some deeper insight into the efficiency of land management operations and understand that this will not be possible solely with the use of information in the public domain. Therefore it is proposed that deep dive comparisons on land management are made with organisations who have agreed to share data which will give insights at the operational programme and project level. Forestry and Land Scotland (FLS) and Natural Resources Wales (NRW) have agreed to collaborate with us - we may be able to persuade others to participate at this level of detailed sharing. We expect that some of the data provided by NRW and FLS will be commercially sensitive and that we will commit to only sharing the final report under restricted cover and fully credit the participation of other organisations.

We have identified the following topic area which we wish to investigate in terms of the efficiency of how Forestry England currently delivers these activities;

- Forest regeneration
- Deer management
- Timber production planning
- Timber harvesting and marketing
- Forest roads construction and maintenance

Resources

Completion of this benchmarking work will require time of existing staff and cash funds for consultancy. Both can be afforded from within existing budget resource.

Communications

Completion of this benchmarking work will require engagement from members of Forestry England staff operating in national and regional roles. It will be of broader interest especially to district Heads of Land Management and Forestry Commission Trade Unions. We intend to use scheduled meetings of these groups of colleagues to inform them of the intent to progress this work and, in time, the results. Initially we will base messaging on the communication headlines above.

Next steps

The Board is invited to discuss and provide a steer on this work. With input from the Board we will finalise the consultants brief then issue an invitation to tender and appoint a suitable consultant. We aim to appoint before 31 March 2023.

Draft - Consultant Tender Brief

Background

Forestry England manages over 250,000 hectares of public land and is the largest land manager in England. We are a DEFRA 'arms length body' and, because we generate more than 50% of our annual expenditure from commercial activity, we are classified as a public corporation. Our annual report and accounts can be found [here].

From time to time we undertake bench marking exercises which help us understand how our operational activities compare with similar organisations and to gain insight which can help us become more effective and efficient.

We last commissioned an organisational bench marking exercise in 2017 (report included in this tender pack*) and we want to build on that work. This work focussed on a range of high level information which is available in the public domain and included a range of UK and international comparator organisations.

In 2019 the process of devolving the GB organisations involved in State forest management was completed and Forestry England was established as part of the Forestry Commission. Forestry and Land Scotland (FLS) and Natural Resources Wales (NRW) perform equivalent roles to Forestry England and all three organisations share a good deal of operational heritage.

With between 5 and 10 years of independent development of State forestry operations in England, Scotland and Wales we now have an opportunity to compare key aspects of our operational efficiency and learn from each other. FLS and NRW have agreed to collaborate with us and share operational information which is not available in the public domain.

Objectives

Forestry England wishes to use external benchmark information, building on the bench marking work undertaken in 2017/18, to compare and contrast Forestry England's current performance with private, charitable and public organisations operating in a similar field.



There are two distinct elements of efficiency benchmarking we wish to explore:

- 1. Organisational level efficiency benchmarking (phase 1) Building on benchmarking work undertaken in 17/18 undertake an appropriate assessment of Forestry England performance at an organisational level relative to peers.
- 2. Work activity level benchmarking (phase 2) Develop deeper insight into the efficiency of land management operations specifically. As well as using information that is publicly available two peers have agreed to collaborate with us to provide relevant information. Data provided will be commercially sensitive and should be restricted.

We have identified the following topic area which we wish to investigate in terms of the efficiency of how Forestry England currently delivers these activities;

- Forest regeneration
- o Deer management
- o Timber production planning
- o Timber harvesting and marketing
- o Forest roads construction and maintenance

We are inviting bids from suitably qualified consultants to assist Forestry England in investigating the efficiency of our operations.

We envisage work progressing between March 2023 and February 2024.

Aims

The consultant's proposal should aim to provide information and insight on both the efficiency elements described above which can contribute towards:

- an assessment of effectiveness and efficiency in Forestry England's current approach to organisational level and forest management work activity level management relative to peers.
- insight that informs appropriate change to strategy, approach and practises, if required, in order to optimise performance overall.

The successful bidder's approach should be to support Forestry England by:

• identifying the most relevant quantitative and qualitative business and people metrics for benchmarking (to be agreed with Forestry England)



- identifying domestic and international peers for benchmarking (to be agreed with Forestry England)
- supporting Forestry England's internal data gathering of the selected benchmarking metrics
- collecting and analysing selected benchmarks for agreed peers
- positioning Forestry England against peers to identify relative efficiency in both business and people metrics.

Specification of Requirements

We will be awarding a contract to review the business efficiency of Forestry England's land management.

Our intention is to award this contract for a period of [xx] months.

The value of the contracted review will be no more than £xx,xxx excluding VAT.

The contracted review will include:

- Organisational level efficiency benchmarking (phase 1)
 - A desk based information gathering exercise drawing material from published sources and from nominated contacts in comparator organisations.
 - Use of appropriate metrics of performance
 - A SWOT and other appropriate analysis summarising Forestry England's current practices, structure and capability in relation to peers
 - Provide a comprehensive report making recommendations on improving organisational performance.
- Work activity level benchmarking (phase 2)
 - Use relevant metrics, alongside qualitative data to identify the efficiency of land management in the agreed focus areas.
 - Provide a comprehensive report and recommendation of options for developing efficient land management practices, structure and capability of Forestry England.

Provide a MS Powerpoint presentation of the key findings and recommendations to our Board (remote - via Teams).
