Background Information

Forestry England are the country's largest land manager, caring for the nation's forests for people, nature, and the economy. The foundation of our organisation is our world-class sustainable management of the nation's forests. Wildlife Management plays a vital role in protecting and enhancing the environmental and commercial value of our forests. We are proud to offer a Wildlife Volunteer opportunity within England's largest red squirrel reserve for an individual with an interest in wildlife management. The role will be based in Kielder Forest and focus on grey squirrel control by live trapping with cranial dispatch. Kielder is the largest man-made forest in England covering over 250 square miles and is home to approximately 50% of England's Red Squirrel Population.

The successful applicant will be given:

- Practical wildlife management experience
- Training relevant to the role.
- Support from a supervising Wildlife Ranger.
- Essential Equipment, (traps, bait etc.)
- Genuine out of pocket expenses which includes travel expenses beyond your reporting station.

- Opportunities to develop and learn from an experienced team of Wildlife Rangers.
- Volunteer parking pass after 35 hours of volunteering.

Wildlife Volunteers

Purpose

Pro-actively assist with Red Squirrel Conservation through the control of non-native Grey Squirrels.

Red squirrels are a native UK species but their numbers have plummeted due to the introduction of the non-native grey squirrel, which outcompetes them for food and spreads the deadly squirrel pox virus. As a result, red squirrels are now restricted to strongholds across the British Isles which have a low numbers or no grey squirrels. Grey Squirrels also cause damage to trees by stripping bark, impacting woodland management and biodiversity.

Key work areas

Assist with Grey Squirrel Control within England's Largest Red Squirrel Reserve.

- Run your own trap line, following all best practice and legal guidelines.
- Reporting to the beat Wildlife Ranger, Brian Scott.

Independent volunteering

Independently carrying out your volunteer role within an agreed work area in the forest and complying with our lone working policies and procedures

Enthusiasm for Wildlife Management.

Ability to listen and communicate with people from a variety of age groups, abilities, behaviours, and backgrounds.

Ability to deal with difficult situations with tact, diplomacy and in a constructive manner.

Essential

Motivated and capable of working under own initiative.

Prioritise and organise your time and resources effectively to meet agreed deadlines and objectives.

Desirable

Understand and apply current legislation, rules, and procedures relevant to the job (e.g., Health & Safety, Risk assessment).

Learn and Apply

Be open to change and show a willingness to undertake appropriate training to develop new skills and confidence.

Take responsibility for own work, learning from experience, mistakes, and constructive feedback.

Able and willing to work flexibly. A commitment of at least 5 days per calendar month.

Hold a full current driving licence. Duties will require you to be fit and able to negotiate rough terrain. However, Forestry England is willing to consider proposals put forward by applicants that would allow them to do the role by other means.

Complete a DBS check and provide references.

When completing the **About You** section of the application please give examples of Essential and Desirable experience, training or study you have for each of the Person Specification sections. These examples don't always have to be in the environment sector they can demonstrate your experience or things you have done in any situation relating to the specification area.
