## Discreet nature-sensitive holiday cabins in Farley Moor Forest

### Matlock Moors



The total woodland area for Matlock Moors is 483Ha. Forest Holidays cabins and facilities are proposed to occupy less than 1% of the total woodland.

New public parking area

A large proportion of the site remains free from any built structures, including recently restocked clearfell toward the centre of the site and areas of Priority Habitat deciduous woodland.

New all-weather trails within the forest

Proposed cabins would be constructed in areas of the existing coniferous plantation woodland.

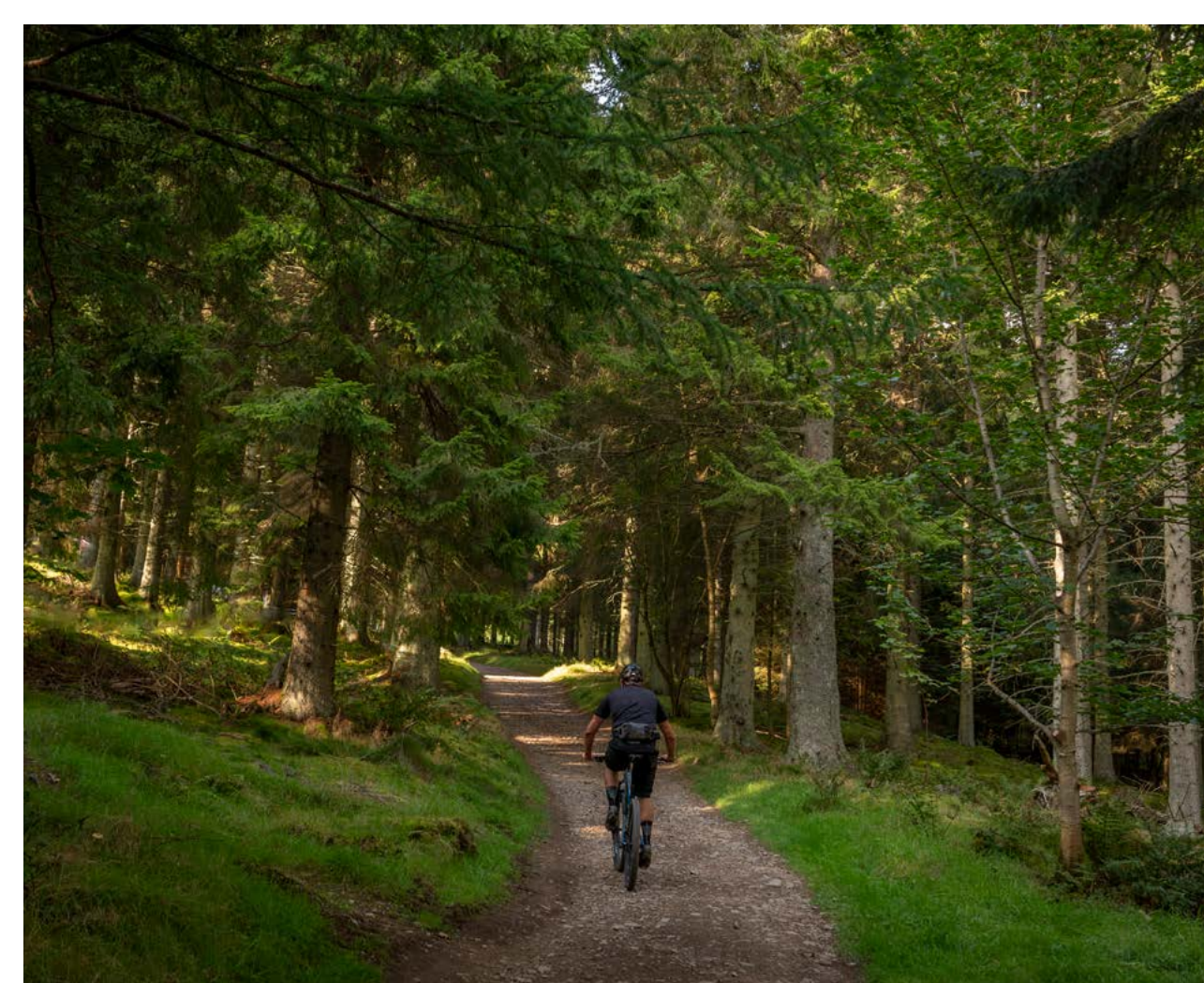


Continuous cover forestry

Forest Retreat with reception, shop and café as well as natural play area and bike hire store

To encourage more local people to spend time in the forest, active discussions are being held, with relevant parties, to improve the existing footpaths within the Matlock forest area. The plans will improve access into the forest with enhanced all weather walking paths and trails and a new public parking area.

Access will be entirely preserved throughout the forest, including the area of the proposed cabins. There will be no fencing or barriers, members of the public will be able to walk around the forest with the same freedom as now.

Forestry England manages the nation's forests to be sustainable and resilient, providing benefits for people, wildlife and the economy both nationally and locally. To ensure as many people as possible can enjoy the nation's forests, Forestry England continually review forests to see how those benefits could improve and look for new ways to access and experience them.

Proposals for 75 nature-sensitive cabins nestled in a small part of Farley Moor Forest have been developed. The forest would remain open for everyone to enjoy, with the cabins, a small café and reception area, a natural play area and bike hire store proposed to only use around 2.5% of Farley Moor.

The proposals are based on decades of experience with Forest Holidays successfully operating 12 carefully placed cabin locations in other forests across Great Britain. The concept for overnight accommodation which is designed to fit thoughtfully within the woodland, was agreed by Forestry England's Board and the Government's Forestry Minister, which has enabled full proposals to be explored, developed, and now shared.

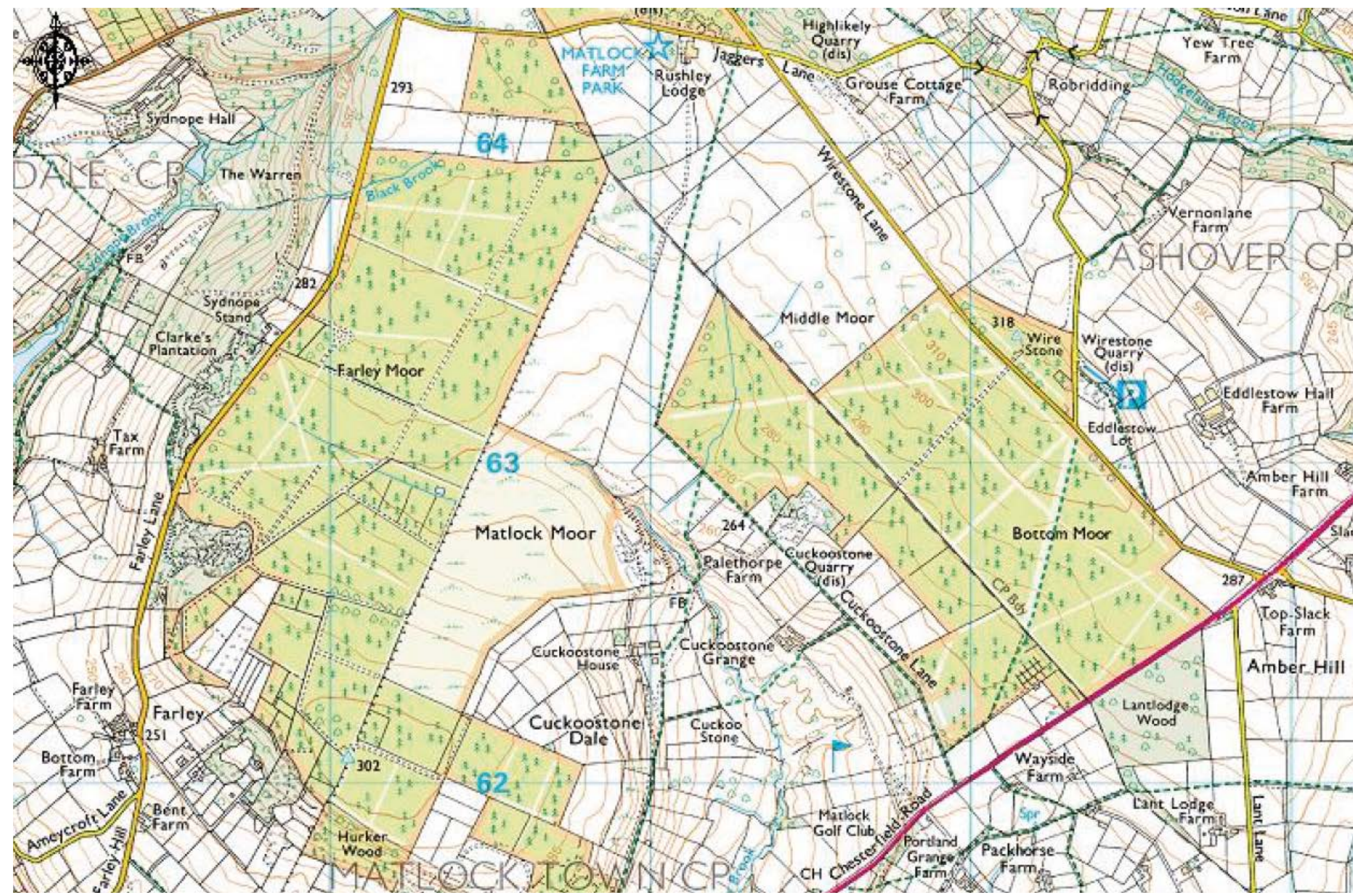

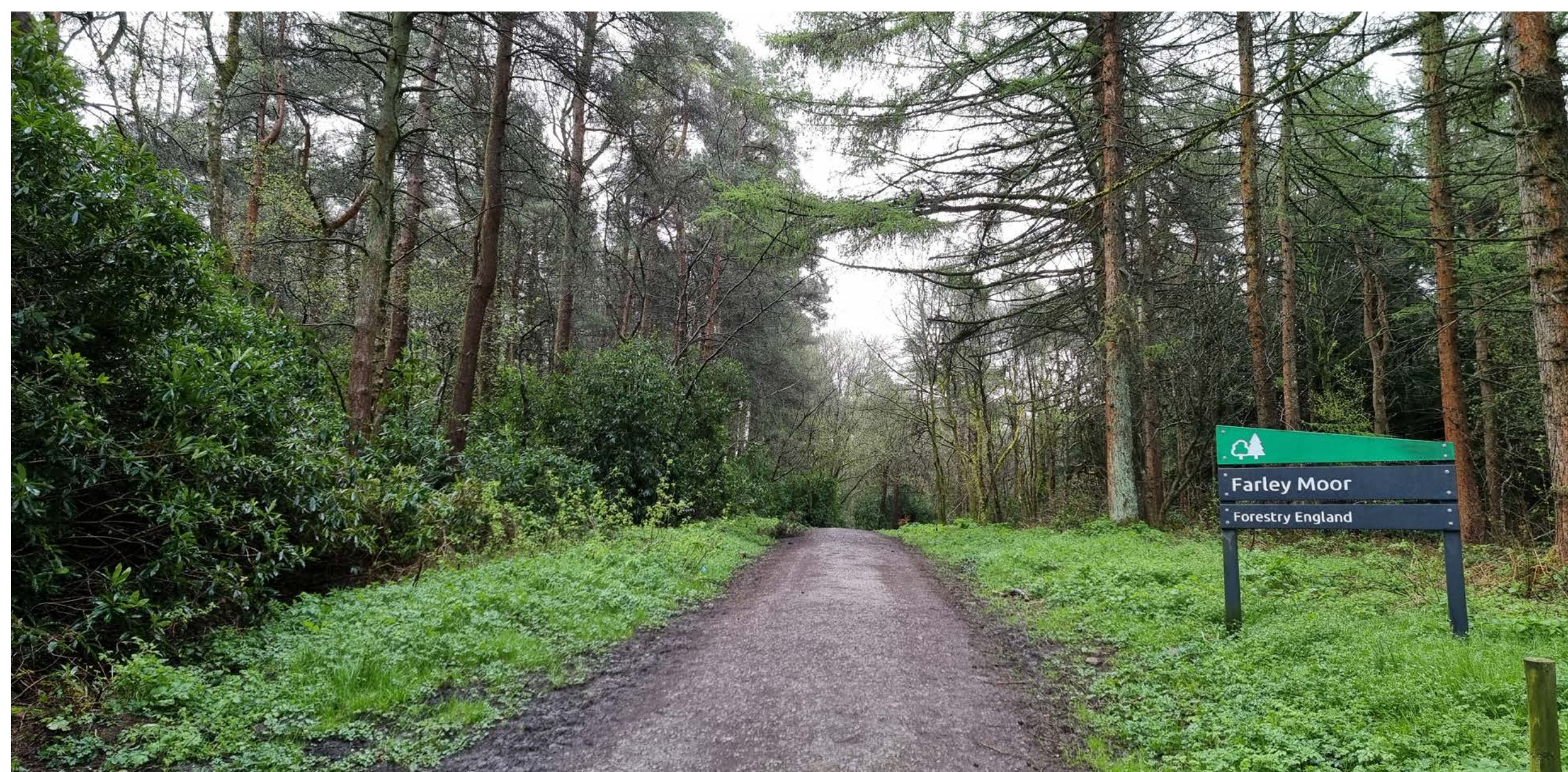
## Farley Moor

Farley Moor is one of seven named woods (Sitches, Whitesprings Plantation, Seventy Acre Plantation, Forty Acre Plantation, Upper Moor, Farley Moor and Bottom Moor) which form Matlock Moors.



Through active forest management by Forestry England, the Matlock woodlands ecosystem now supports a diverse range of wildlife, although Farley Moor largely comprises plantation pine of limited diversity. The proposals have evolved in collaboration with Forestry England to ensure that they continue to satisfy the economic, social and environmental objectives of the Forest Plan. The proposals will deliver a 'Biodiversity Net Gain' and after construction of Forest Holidays cabins, the woodland and habitat will be managed in accordance with Habitat Enhancement and Woodland Enhancement Management Plans.

*Biodiversity Net Gain (BNG) is a legal planning requirement that aims to leave the natural environment in a measurably better state than it was beforehand.*



## Forest Holidays proposals adhere to the principles of Biodiversity Net Gain

As landowner, Forestry England has established a set of guiding principles and core requirements which Forest Holidays are legally obliged to adhere to. These include principles that require development to be designed, built and managed in a sustainable manner with minimal environmental impact and help to manage the site and surrounding woodland to Forestry England standards. The land is part of the nation's forests and continues to be owned and managed by Forestry England.

The robust and long-term partnership is managed through a high-level legal agreement. Each Forest Holidays location in England also has a site-specific lease which specifies how each site is managed, as well as detailed conditions included on each planning consent. Through all of these different agreements, how the cabin locations are managed and what happens to them in the future is very tightly controlled. Forest Holidays are stewards of 244.5 hectares of UK forests and their business is designed to respect nature and benefit ecosystems. Forest Holidays locations positively impact and conserve the environment whilst creating space in nature for people to stay overnight in a well-managed, ecologically diverse, and quiet forest setting.

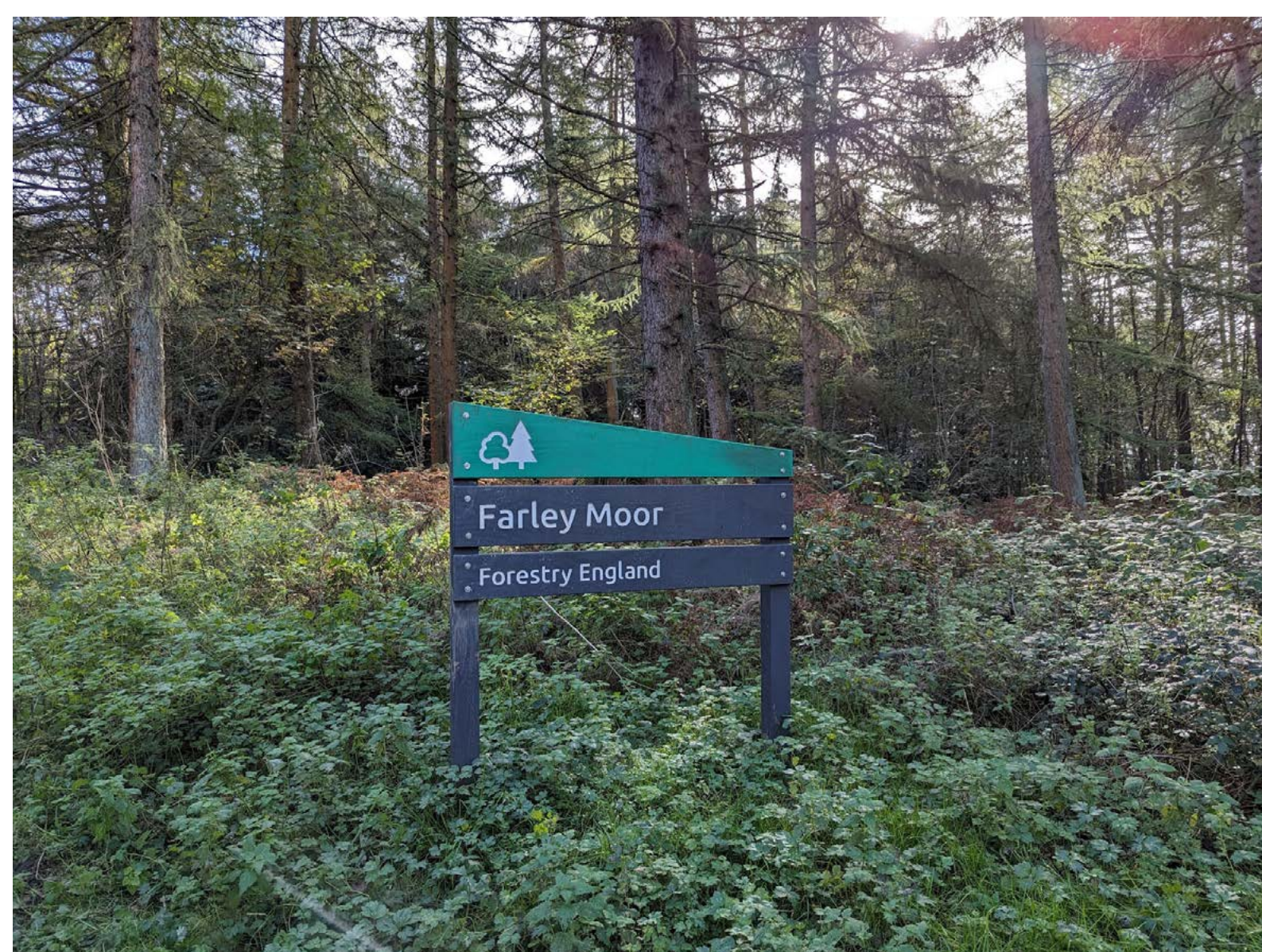

# Taking time to select the right location

## How this location was selected

The site selection process and assessment criteria of any potential new Forest Holidays location is conducted in accordance with Forestry England policy guidance. Sites undergo a rigorous internal assessment process which is included in a submission to the Secretary of State to request consent to grant an option to lease. This assessment includes reference to: Planning and Environment; Conservation, Wildlife and Landscape amongst others.

The concept for overnight accommodation which is designed to fit thoughtfully within the woodland, was agreed by Forestry England's Board, and Forest Holidays was granted an 'option to lease' from the Government's Forestry Minister in 2023, which has enabled full proposals to be explored and developed.



As a result of this process, Matlock Moors forest block was identified as a suitable location for overnight accommodation.

Farley Moor was selected as the most appropriate area of the wider woodland and in-depth ecological assessments and surveys confirmed that the forest is suitable.

## Next steps in planning

Following the public exhibition, Forest Holidays and Forestry England will consider the comments which have been made, and where necessary look to refine the proposals, and then aim to submit a planning application to Derbyshire Dales District Council.

## Proposed timeline for the project

- Discharge of planning conditions
- Set up of construction site, with community liaison
- Construction of cabins and associated infrastructure
- Creation of ecological enhancement areas
- Once cabins are operational, links with local businesses established
- Ongoing ecological monitoring and woodland management



## A methodical approach, examining multiple factors

A full suite of studies, including assessments for protected species, have been carried out over recent years and will be included within a full planning application.

These include:

- Landscape and Visual Impact Assessment (LVIA)

### Ecology and wildlife

- Habitat survey
- Ecological Assessment Report (Ground flora, badgers, bats, reptiles, great crested newts, invertebrates and birds including Nightjar)
- Biodiversity Net Gain (BNG) Assessment
- Habitat Regulations Assessment
- Ecological Procedural Method Statement
- Habitat Enhancement and Management Plan

### Trees

- Tree survey
- Arboricultural Method Statement
- Woodland Management Plan

Long-term management will see Farley Moor transition from plantation pine to a more diverse and species rich continuous cover native woodland.

- Transport Assessment
- Outline Travel Plan

### Heritage

- Archaeological Assessment

### Economy

- Economic Impact Assessment

### Drainage

- Flood Risk Assessment
- Drainage Impact Assessment

Severn Trent Water has been consulted and provided sufficient detail for them to confirm that the mains sewers have the necessary capacity for the foul water from the proposed development.

The design of the on-site drainage system will allow flow rates to be controlled, via an on-site holding tank, to restrict flows to non-peak times only and at a rate that has been agreed.

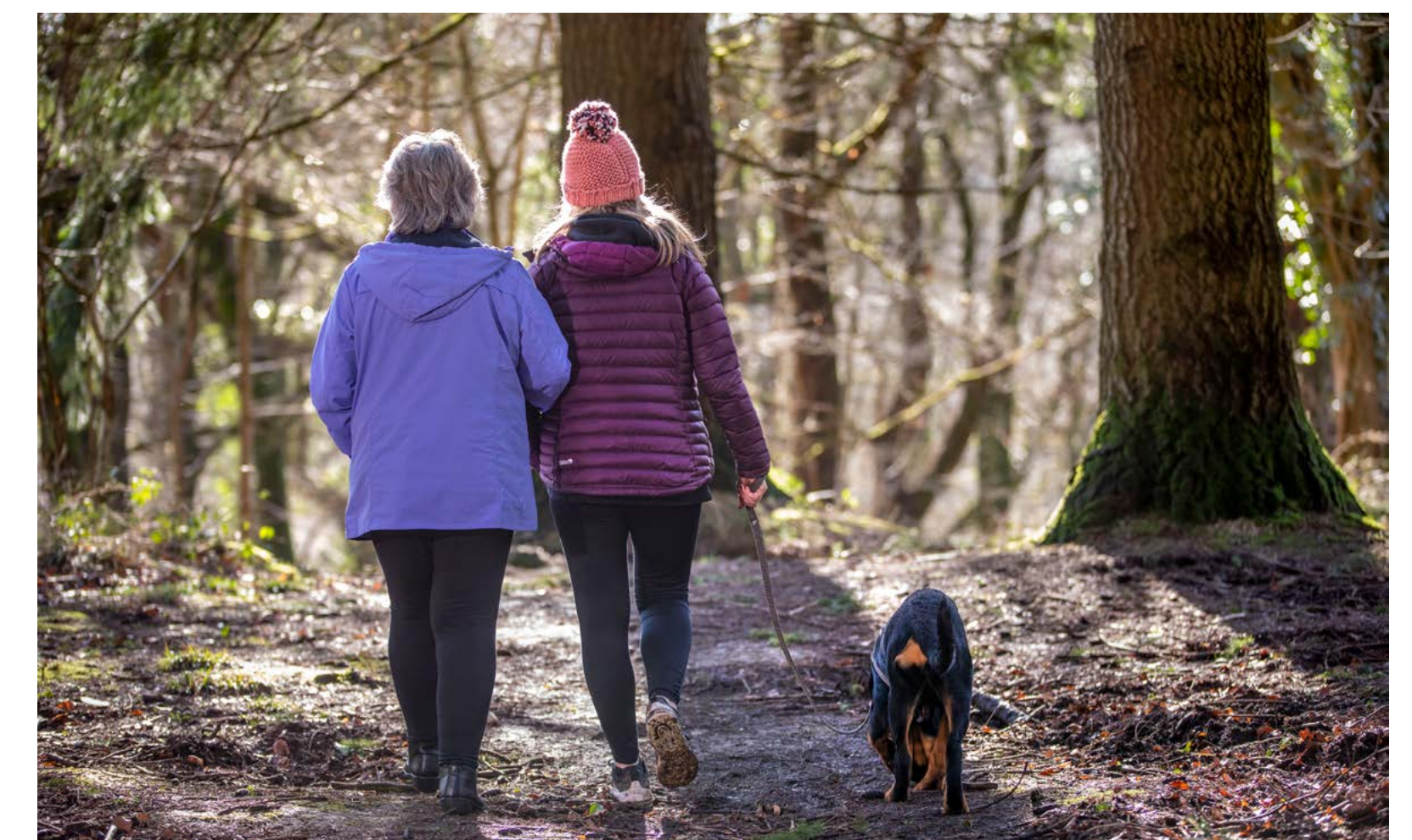

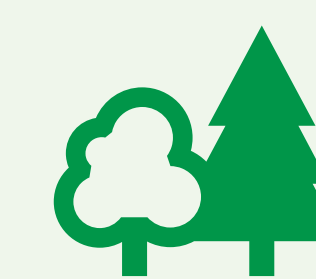

## Supporting your local area

The sensitively placed cabins at a discreet and contained location within Farley Moor, would give visitors a chance to stay overnight and explore the forest in a new way which would generate additional year-round jobs and income for the local economy. The proposal would be well screened, appropriately scaled for the location and enhance and expand the breadth of the tourism experience.

Forest Holidays champions sustainable tourism, offering an unpackaged experience which encourages guests to visit local attractions, explore the surrounding areas and eat, drink and shop locally during their stay. It is estimated that visitor spend in the area will provide a boost of £1.7 million per year to the local economy and generate new employment opportunities both during the creation of the cabins and by direct employment with Forest Holidays.



## Supporting the management of the forest

Forestry England receive less than a fifth of their income from Government and generate most of their revenue themselves by sustainably harvesting and selling timber, visitors and membership support and by working with commercial partners to offer new ways to experience and enjoy woodlands and develop business activities. All of their income goes back into creating thriving forests for people to enjoy and homes for wildlife.

Forestry England plays a key role in supporting businesses and local economies around the country. Across the nation's forests they support over 640 private businesses through their cafés, shops, recreational, woodland and estate management.

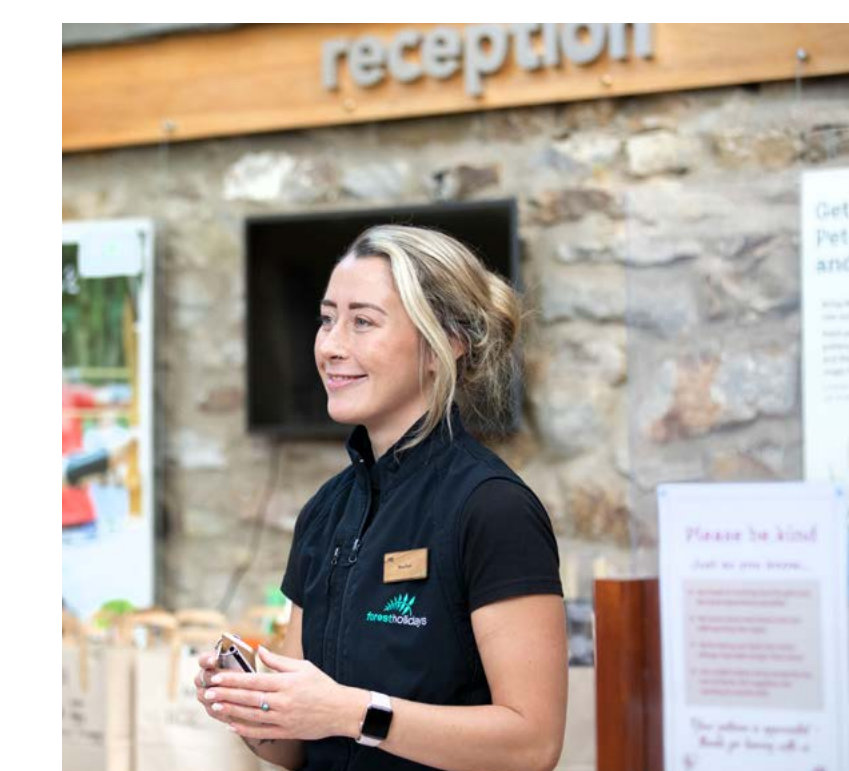
Tourism is an important economic, social and cultural asset and the sector is a major contributor to jobs and growth in the UK.
