Background Information

Forestry England are the country's largest land manager, caring for the nation's forests for people, nature and the economy. The foundation of our organisation is our world-class sustainable management of the nation's forests.

The Central Forest District has responsibility for the management of some 30,000ha of the Nation's Forests within a triangle formed by Liverpool, Hull, and Milton Keynes. This gives rise to a large diversity of users, customers, neighbours and pressures, all of which are interacting on a varied backdrop of land uses.

Cannock Chase Forest (CCF) covers 2684 hectares of coniferous and broadleaf woodlands and open land in Staffordshire in the West Midlands, between the towns of Stafford to the northwest, Cannock to the south and Rugeley to the east - Birmingham city centre is 20 miles to the south.

Most of the forest is freehold as part of the public forest estate and is designated as Open Access land. Much of the woodland in the west and north eastern corner of the plan area is leased to the Forestry Commission however, and access in these areas is restricted to Public Rights of Way.

The area lies within the Cannock Chase Area of Outstanding Natural Beauty (AONB) and the majority of Forestry England land is made up of conifers planted for timber production. There are also areas of ancient woodland, wetland, wood pasture and open heathland within the forest. Adjacent lowland heath is internationally important and is designated as a Special Area of Conservation (SAC).

Shadow Volunteers

There are many archaeological features within the AONB and the forest has a long history of hunting, grazing and mining. Evidence of more recent military training includes a first world war model trench system at Brocton, which is a Scheduled Monument.

Cannock Chase Forest welcomes around 400,000 - 500,000 visitors to the forest each year and provides a wide range of outdoor activities. CCF has a range of recreation offers for families and individuals including play, Go-Ape and a network of cycle trails. Cycle trails range from Easy Green trails to Intermediate Blue and Difficult Reds.

We are looking for an individual to join the Recreation team to support trail management, visitor Services and the wider recreation team.

Successful applicants will be given training and development opportunities by work shadowing the Recreation team at Cannock Chase Forest. They will develop on the job skills; including development of customer service, learning techniques, leading and working with groups and planning and running events, practical site management and working/leading volunteers.

What we offer

- Training relevant to the role from your experienced member of staff you are shadowing along with gaining knowledge from wider colleagues.

Supporting the Recreation Rangers and visitor services team to provide outstanding customer experiences at Cannock Chase Forest. Within the team you will have opportunities to; welcome visitors, support and supervise volunteer groups, and maintain the forest centre by completing facility inspections and carrying out associated maintenance, ensuring a safe visit for all.

Essential

Interest in the environment, Forestry England, woodland management, recreation, or customer service in an outdoor setting.

Desirable

Experience or interest in environmental or outdoor work, customer service working with volunteers, practical site management, delivering sessions to a variety of groups; through previous employment, voluntary work, or study.

Willingness to work as part of a team as well as the ability to work on your own.

Experience of working with people from a wide range of social backgrounds.

However, Forestry England is willing to consider any proposal put forward by applicants that would allow them to do the role by other means. This role will require a DBS check.
