## Cycling to Bourne Wood

You can get to location by bike from Farnham Rail Station with a journey time of approximately 15 minutes. The initial section of Tilford Road to Alfred Road is part of the National Route 22 (NCN 22). NCN 22 provides a route from Banstead to Brockenhurst in the New Forest via Dorking, Guildford, Farnham, Petersfield, Havant, Portsmouth, Ryde, Yarmouth, and Lymington.

## Parking for filming activities

Designated informal parking areas for the filming activities are available closer to filming sites, within the north-eastern side of Bourne Wood and along forest tracks that are not public rights of way.

The management and responsibility for any parking activities that take place off-site rest solely with the film company operating these arrangements.

## HGV, service and delivery vehicles



Film companies and their managers must liaise with the Bourne Wood Travel Plan Co-ordinator to confirm their HGV/service and delivery vehicle routes, in addition to confirming the size and types of vehicles expected to require access to Bourne Wood. The most appropriate routes will then be confirmed to the film company by the Travel Plan Co-ordinator in advance of any trips being undertaken to/from the site. The film company must adhere to the agreed route at all times. Only in exceptional circumstances must alternative routes be used.

The A31 Farnham Bypass is the primary trunk road for vehicles accessing the site from the north. HGV and service/delivery vehicles accessing the site from the south-westbound carriageway of the A31 (originating from the direction of Guildford/Farnborough) will route southbound along Station Hill and then Tilford Road, providing the most direct route to and from the strategic road network. Vehicles traveling north-westbound along the A31 Farnham Bypass (from the direction of Winchester) wishing to travel southwards towards Bourne Wood are unable to turn right to travel southbound onto Station Hill due to a right-turn ban at the A31 Farnham Bypass/Station Hill junction. In order for vehicles undertaking a permitted left turn at this junction to access Bourne Wood, they would need to route north along South Street, westbound along Union Road and southbound along Long Bridge and Firgrove Hill for picking up routes south and eastbound towards Tilford Road and Bourne Wood. However, Union Road is within Waverley Council's Farnham Air Quality Management Area. Drivers of vehicles associated with filming activity at Bourne Wood are instructed not to use the A31 Farnham Bypass/Station Hill junction and instead use alternative junctions and routes to the site.

Alternatives: Vehicles up to 4.2m (13 ft 9 in) in height - Leave the A31 Farnham Bypass at the Coxbridge Roundabout and route via the A325 southbound. This junction is the preceding major junction upstream of the A31 Farnham Bypass/Station Hill junction and could be used to pick up routes south and eastbound towards Tilford Road and Bourne Wood via Wreclesham and Shortheath. However, the A325 is subject to a height restriction associated with the railway bridge immediately north of Weydon Lane and therefore this route is only accessible for vehicles less than 4.2m(13 ft and 9 in) in height.

Vehicles of any height - Leave the A31 Farnham Bypass turning right to route south and westbound on Weydon Lane. The A31 junction with Weydon Lane is a signalised intersection located approximately mid-way between the Coxbridge Roundabout and the A31 Farnham Bypass/Station Hill junction and permits over-height vehicles to bypass the A325 4.2m height restriction. It connects with the A325 immediately south of the railway bridge which is subject to the height restriction, to pick up routes south and eastbound towards the site. It is recommended that the default route to the site from the A31 Farnham Bypass for vehicles on the north-eastbound carriageway is via Weydon Lane. For trips in the reverse direction (i.e. from Bourne Wood towards the A31 Farnham Bypass), vehicles can access the A31 Farnham Bypass to travel in either direction via Tilford Road, Station Hill and its signalised intersection with the A31 Farnham Bypass.

At all times, the filming company must be aware of the following restrictions affecting route choice for north-westbound vehicles on the A31 (originating from Winchester direction):

- No access at any time southbound towards Bourne Wood via the A31 Farnham Bypass/Station Hill junction.
- Access northbound and southbound via the A325 and Coxbridge Roundabout restricted to vehicles less than 4.2m (13 foot and 9 inches) in height.

Vehicles of any height can use Weydon Lane/the A325 to pick up routes south and eastbound towards Tilford Road and Bourne Wood.
